#### SEMEN RIGHTS ON ALL WALLALOO PARK RAM SOLD

In purchasing a ram from this catalogue, you are agreeing to the terms of semen rights as detailed below:

- 1. Wallaloo Park retain 50% of semen marketing rights of all rams sold, these rights are permanent unless otherwise agreed in writing
- 2. The purchaser of an animal has the right to use the ram either in the form of natural service or artificial breeding in the purchaser's own flock. The Purchaser does not have the right to sell, gift or trade either semen or services from the ram to another entity.
- 3. In the event that there is more than one purchaser of an animal, all purchasers need to be clearly listed on the buyers card when registering prior to the start of the sale. Only purchasers listed on the buyers card are able to use the ram naturally or using artificial breeding methods.
- 4. The Purchaser agrees to allow Wallaloo Park to collect semen from the ram at a time that is mutually convenient. Access to the ram cannot be unreasonably withheld.
- 5. If the rights of ownership are transferred to another entity, these rights must be transferred in full (not partial rights) and the semen rights agreement as laid out in points 1,2,3 and 4 is transferred with the ram to the new owners.
